2. What's New: Provides users a quick reference of changes, enhancements, and other items of note in HEALTHE NL. By clicking on the link "<u>here</u>", a PDF file opens in a new window displaying what's new in HEALTHE NL.

3. Global Menu: Refers to your account information and the Home, Help and log out options at the top right of the screen. It is always accessible from any screen within the HEALTHe NL Viewer.



- The Home icon returns the user to the Clinician Homepage and refreshes the contents of the page.
- The Message Indicator displays the number of unread messages. It appears in red if one or more of the messages has been identified with High importance, containing an exclamation mark ! inside the bell. Besides an indicator appears at the bottom right corner. If no

 - By clicking this arrow the 'User settings' and the 'Help' link appears.
 Click 'User settings' to go to "My details" page. Click 'Help' to launch the built-in help files.

Logout – Will immediately log you out of the system. Timeout is **35 minutes** of inactivity (**30 minutes** if you accessed HEALTHe NL through the internet), after which time the system will log you out. Using the **X** button, in the top right of your browser, will close your window but will not log you out of HEALTHe NL.

- 4. **Patient Demographic Search**: Displays search fields enabling the user to search for a patient directly from the Clinician Homepage.
 - Access via the clinician homepage or the left menu.
 - Recommended search via MCP #, search by other patient's identifiers is available (e.g. St. Pierre and Miquelon HCN, CRMS number, etc.).
 - If a patient has masked his/her profile, it will appear as a lock icon next to his/her name.
 - If a patient has been merged, the user will see the merged patient indicator anticentering indicator anticentering indicator and the patient's name. The patient's record can't be opened until the patient is manually removed from any user worklist, (including the 'Recent Patients' worklist) the patient may appear.
- 5. **Recent Patients:** Displays the patient records the user has previously viewed classified by the following periods.

- 7. **My Worklist:** This area contains 6 lists (by default named with colors red, blue, yellow, green, orange, purple) that you can customize by clicking Rename button next to the worklist name.

 Patient Context Bar: Displays patient's information (name, date of birth -DOB-, gender, and MCP). If the patient is deceased, a DECEASED label appears next to the MCP number.

In the Patient Context Bar, clicking the Context Lists icon $\langle \equiv \rangle$ displays the list of patient search results or worklists entries, allowing a different patient to be selected. Additionally, the \triangleleft and \triangleright icons can be used to change the patient in context to the previous or next patient in the list, respectively.

Clicking the x icon next to the Context Lists icon closes the Patient Dynamic Summary and returns to the previous page the user was using before the patient was brought into context.

Clicking the plus + icon next to the patient's name (left corner) displays the available worklists. You can add the current patient to a specific worklist by selecting it. Once you select a worklist the plus + icon changes to a coloured icon. If the patient is currently on a worklist, the flag's background colour will match the colour of the flag associated with that worklist. If the patient is on two or more worklists, the background colour will match the first worklist the patient has been added to, based on the order displayed in the drop down list (red, blue, yellow, green, orange and purple).

- 2. Patient Record Tabs
- **2.1** <u>The Patient Summary tab:</u> It is the first screen you see when a patient's name is selected from a worklist or the results of a search. The patient's information is displayed in 3 sections.
 - **a.** <u>Demographics</u>: Lists the patient's personal and contact details. If the patient is deceased, this is indicated by the presence of the

DECEASED label alongside his or her name. The information displayed is shown below:

Identifiers: All available identifiers are displayed (E.g., MCP, Unit #, Out of Province HCN, St. Pierre and Miquelon HCN, etc.).

Demographics: Including gender date of birth, age, address, available phone numbers, alternate names, organ donor flag, and advance health care directive.

- b. <u>Allergy Summary</u>: Lists the patient's recorded allergies. The information displayed includes the Agent, Severity (Reactions), and Created date. Red font denotes Severity of the Allergy "High".
- C. <u>Adverse Drug Event Summary:</u> Lists the patient's recorded adverse drug event. The information displayed includes the Agent, Severity (Reactions), and Created date. Red font denotes Severity of the Adverse Drug Event "High".





Timeline tab: Provides the user with an overall perspective of a patient's medical history using a visual representation of encounters and documents available for that patient. It shows the information for that patient. It shows the information for a patient presented according to when that information was generated or received,

- To see the details of an item on the Timeline, hover the mouse over the selected ٠ node. To open the document, click "Open document". Click the "Timeline" link to go back to the timeline.
- To zoom in on a specific timeframe, select a time frame in any section of the Master Timeline and the sub-timelines will displayed only the specified timeframe. Click the "Reset Zoom" link to redisplay the full timeline.
- To see what the markers mean, click the "Show Key" link above each section of the timeline to display the key for that section.
- To hide the section of the timeline, click the Collapse 🔻 icon to the left of a timeline. •

Encounters tab: Displays a list of the patient encounter's history (pre-admissions are not included), there are 3 types of encounters HEALTHe NL displays: Emergency, Inpatient and Outpatient (includes Ambulatory, Recurring and Surgical).

2.2 The Medication Profile Tab: It opens the "Prescriptions" page, displaying the Prescription Summary section. This section is sorted by "Last Dispensed" column, having the most recent dispensed medication (of the newest prescription) at the top.

- 2.3 The Referrals Tab: It provides access to eOrder, eConsult, eTriage Assessments (not currently in use) and Cardiac Cath. Lab (myCCath).
- The Immunizations Tab: It provides patient immunization records and related adverse reaction data sourced from the Provincial Client and Referral Management System (CRMS) for patients born 2003 or after. Immunization records for patients born before 2003 may exist in the Communicable disease Control office in your Regiona Health Authority. The contact numbers may be found on the Clinician Homepage under LINKS > CDC Contact info links (To see how to get to LINKS see page 1, Left menu section).

Electronic Death Notification Tab: This tab links pre-approved roles to access a fillable document regarding a patient's death information.

3. CDV Tree: Displays all the current reports for the selected patient. By default the reports are grouped by category and subcategory. The category is only visible when there are patient reports available in that grouping; otherwise, the category is not displayed.

Report Categories: All reports are displayed as links in the CDV Tree and have been classified into categories.

- **Read/Unread:** The CDV tree indicates the number of read/ unread reports (in brackets) in a given category, for the current user.
- **Popover/Tooltip:** When viewing reports in the CDV tree and hovering the mouse over a report, a popover/tooltip appears, providing the user with information about the report. The popover for each report contains the following attributes: Title, Source Date, Category, Service, Author and Source. (Only displayed if present in the CDR).

The popover contains links that allow the user to mark the document (or multiple documents if viewing a link for a cumulative report) as Read or Unread.

- **Date Range Filtering, Grouping and Sorting:** By default, the reports contained in each folder are displayed by date in descending order, beginning with the most recent (within the folder). However, this order can be changed and the reports can be filtered by date, group or sort.

Selecting the "Document View Control" ^(O) icon will display the Show, Group by, and Sort by options to select. Choose the option you desire and click "Apply".



• <u>Searching:</u> The CDV tree can be searched with free-text to find any reports that have an attribute matching the specified text. To perform a search click the "Search" Q icon, the search option is display, then type the desired search text in the text box.



This icon is used to show documents not signed off. Document sign-off is not configured in the HEALTHe NL Viewer, thus this icon does not have any functionality for now.

This icon is used to show documents that have been marked as important. None of current documents display in the HEALTHe NL Viewers are marked with importance (only abnormality), thus this icon does not have any functionality for now.

Any comments associated with the report are automatically displayed after all other header fields. Suppressed when no such comments exist.

The Results panel displays the textual dictated report.

In the case of **cancelled** or **pending** reports, the textual report is not shown and an "**Unavailable** Cancelled/ Pending report is not available" message is displayed instead.

In the case that a report has been **retracted** a message saying "**Unavailable** retracted – please refer to the Meditech source system to view the report."

- Laboratory Reports: Laboratory category contains 5 subcategories: Blood Blank, Chemistry, Hematology, Microbiology and Pathology. This section describes the functionality common to viewing reports in the Blood Bank, Chemistry, and Hematology subcategories. Microbiology and Pathology are not included in this section since they are textual reports.
 - <u>Blood Bank, Chemistry, and Hematology reports</u> are typically numeric results displayed in a table or panel format but may also include textual observations or comments. Only these reports are "rolled up" in the CDV tree, so multiple reports of the same type have one line entry in the CDV tree.

When reports are rolled up, they are displayed in cumulative view when selected from the CDV tree. The date and abnormality indicator (if any) shown for rolled up reports in the CDV tree is the date of the most recent report in the set of rolled up reports.

<u>Cumulative View</u>: Presents a series of reports of the same type (E.g., Same report mnemonic code) over time. It helps in quickly identifying any trends or patterns that may be present for a series of test results. They are presented in a tabular view, in ascending order by Collected Date, with the five newest reports being presented first in the default view.

When viewing cumulative reports, a table is displayed with the following sections (*Figure 5*):

- i. Cumulative Header
- ii. Cumulative Body (results)



The **Source** may have an indicator preceding it such as **1**, **2**, **3**... This indicates that a report-level comment exists for the report, which may be viewed in the <u>collection details hover</u> over of the cumulative header.

The <u>collection details hover</u> allows the user to view additional information about the report. From the cumulative view hover over the collected date and below this date more collection details will be displayed in a small screen.

<u>Cumulative View: Opening an Individual Report</u>

Before a user can see an individual Blood Bank, Chemistry or Hematology report, the cumulative view is opened. To see an individual Blood Bank, Chemistry or Hematology report, the following steps need to be followed.

- o Click the report link on the CDV tree.
- The Cumulative View is displayed which contains a table of this report's test results over.
- Click on its Collected Date (In the Cumulative View) to access the individual report.

Cumulative View: Graphing Results: Graphs plot up to 10 individual results which have been selected from the Cumulative View. Note that only numeric results may be shown in the Graph View; textual results are not included and may not be selected for graphing if all the results in the series are textual.

To view multiple numeric results in a graph:

- 1. Select the report from the CDV tree. The results are displayed in the Cumulative View.
- 2. Select the results to include in the graph (up to a maximum of 10) by clicking the checkbox next to the results, or select all results by clicking the checkbox in the Cumulative Header.
- 3. Click the Graph button. The graphed view is displayed.

The Graph View consists of the following graphs:

Overview Graphs 0



Each Individual graph represents a test involved in the result. The graph shows a data point for each result value.

The Overview graph shows the different test results over time on a single graph, where each line represents a particular test. The legend for the line colors are displayed below the graph.

The **Source panel** displays a separate button for each information source with an indication of how many data points on the graph came from that source. In the sample screenshot, the Overview graph includes 11 data points sourced from "Health Science Centre." and 1 data point from "Waterford Hospital." By default, the graph displays the results from all sources. To exclude the results provided by one or more sources, click the corresponding button on the Sources panel. Click the button again to show the data points from that source.

The Overview graph allows the user to zoom into a specific period to be displayed on the individual graphs. The mouse is used to highlight a specific area or period on the Overview graph. This action automatically changes the zoom level for the individual graphs below. The individual graphs are automatically refreshed to reflect the period specified on the Overview graph.

The **pink zone** in Individual graphs represents areas outside the corresponding reference range. If any point in the graph has a differing reference range or unit, the § symbol is displayed next to the title of the graph.

Additional information may be viewed for each data point on the graph by hovering the mouse over it. The hover displays the same information as the Result Details Hover in the Cumulative View. Please see "Result Details Hover" for details (page 8 – left side).

Cumulative View: Printing Graphs

- The Graph View may be printed by selecting the Print link in the upper right corner of the Graph View page.
- Depending on the user's modification of the Graph View, not all results may be printed in a single printout. It is therefore recommended to print reports using the single report view.
- A warning: "MAY NOT CONTAIN ALL AVAILABLE RESULTS AND DATA" 0 is displayed on the printed presentation of the Graph View to advice users about the completeness of the data.
- A "patient sticky" is displayed in the upper left with the patient's 0 name, gender, age, date of birth, and MCP number to identify the patient.
- The **HEALTHe NL Disclosure** is displayed at the bottom of the printed 0 presentation to warn users about the accuracy and completeness of the information.

- Textual result may be comprised of route, dose, and cost information. 0
- Textual Result is followed by the susceptibility description in parentheses. If 0 the organism is susceptible to the drug, the result is coloured in green bold font; the table row background is also subtly highlighted. Otherwise, the result and row are displayed in normal font.
- By default, the Related Reports section is collapsed. To expand this section 0 and view the reports contained within click the Expand icon . To collapse the section click the Collapse icon

Pathology reports are textual reports. When a user clicks a Pathology Report link in the CDV Tree the report is displayed.
