On Nov 6, NLCHI co-hosted the Modern Consent Design Jam in St. John's. A sprint-like event, the goal was to develop a modern real-time consent model to support patient access. The event was made possible by the Office of the Privacy Commissioner of Canada Contributions Program. Partnering with NLCHI was Infoway Canada, Memorial University, Hacking Health St. John's, Eastern Health and the Government of Newfoundland and Labrador. Prescription Monitoring Program - NL

NLCHI is the administrative lead for Prescription Monitoring Program – NL. Prescription monitoring programs can help improve drug prescribing, lower or prevent risks related to certain drugs, and can help identify patients who may be at risk of addiction.

Information generated from PMPNL is shared back to clinicians to help promote appropriate prescribing and dispensing practices and to provide education. Between July 2018 and June 2019, during the program's first year, there was an average of 4,602 fewer opioid prescriptions dispensed per month, compared to the previous year.
